 TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of

Twenty five hundred

DOLLARS,

 with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured  
 hereby, advanced by the said The Lawrence Building and Loan Association to the part 1st of the  
 first part upon 25 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 1693, which said shares  
 have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part 1st  
 agree to pay monthly installments, making a total monthly payment of \$ 31.75, payable as follows: Thirty one and 75/100 Dollars (\$ 31.75)

 on or before the last day of October, 1931, and a like sum on or before the last day of each and every  
 month thereafter to and including the month of September, 1941.
