The East Eighteen (18) feet of the West 20 feet of Lot 85 on High Street in the City of Baldwin.

 TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in
 anywise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of

Two Hundred and no/100 ----- DOLLARS,
 with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured
 hereby, advanced by the said The Lawrence Building and Loan Association to the part y of the
 first part upon 2 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 1704, which said shares
 have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part y
 agree to pay monthly by installments, making a total monthly payment of \$ 6.36, payable as follows:

Six and 36/100 Dollars (\$ 6.36)
 on or before the Sixth day of November, 1931, and a like sum on or before the last day of each and every
 month thereafter to and including the month of October 1934.
