Northwest corner of the Northeast Quarter (4), Section Six (6), Township Thirteen (13),  
Range Twenty (20); thence South One hundred Six (106) feet for a point of beginning;  
thence East One Hundred Fifty (150) feet; thence North Fifty (50) feet; thence West  
One Hundred Fifty (150) feet; thence South Fifty (50) feet to the point of beginning.TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in
