Trust Deed

THIS INDENTURE, Made this First day of July, 1935, by and between J. R. Holmes, President, and J. M. Sanderson, Secretary, of the Board of Trustees of The First Presbyterian Church of Lawrence, Kansas, hereinafter called "Church Trustees, parties of the first part, and The First National Bank of Lawrence, Kansus, a corporation duly organized and existing under and by wirtue of the banking laws of the United States and having its place of business at Lawrence, in Douglas County, Kensas, herein-after called the "Trustee", party of the second part.

WITNESSETH: That, whereas the said Church Trustees are the duly elected, qualified and acting Trustees of The First Presbyterian Church in the City of Lawrence, Douglas County Kansas, and, as such, under the laws of the State of Kansas, hold title to the real estate hereinafter described for the bene fit of the said The First Presbyterian Church and have power to borrow money for the purposes of the said Church, and

MEREAS, The said Church, through action of its official body, desires to borrow money for the purpose of refunding the present outstanding bonds and to pay other inititedness, all for the purpose of promoting the work of The First Presbyterian Church in the City of Lawrence, Duglas County, Kansas, and the community thereabout, and for such purposes is about to make and issue its first mortgage bonds in the sum of and on the terms as hereinafter set forth in a total amount of \$28,000.00, and

WHEREAS, The borrowing by said Church Trustees on behalf of such Church of the amount of such loar, and the execution and delivery by such Church Trustees on behalf of such Church of such bonds in the and the excention and delivery by such Church Trustees on behalf of such Nurch of such bonds in the form horeinafter set forth, widencing such indebtdness, and the excention, andamoledgement and delivery by such Church Trustees, the proper officers of such Church, on its behalf, a Trust Deed or Mortgage for the purpose of securing the payment of such indebtdness in the sum hereof upon the property of said Church hereinafter described, has been authorized and directed by resolution of the official body of such Church, duly passed at a regularly called meeting thereof in accordance with the rules and regulations of such Church, at which meeting a majority of the official body were present and voted for the adoption of such resolution as spread on the records of such church, and

WHEREAS, Such bonds are to be of even date herewith, to be fifty-six in number, numbered consecut ively from one to fifty-six, both inclusive, being in the sum of \$500.00 each, the principal of said bonds to be payable on the first day of July, 1945, subject however to the privilege of payment before the maturity thereof as provided by such bonds and the provisions of this instrument at the election of said church frustees; each of such bonks bearing interest at the rate of five per control of some from the first day of July, 1935, mayable semi-annually on the first days of January and July of each year, and have attached to them interest coupons for all installents of such interest as well as a Trustee's Certificate of identification endorsed on each of such bonds, the said bonds and interest coupons being of substantially the following form, to-wit:
