

## MORTGAGE RECORD No. 79

It shall not be the duty or responsibility of the Trustee to see to the recording of this instrument, or to the doing of any other act which may be necessary hereunder, nor for the giving of any notice of lien or the calling of any of the bonds secured hereby, nor shall it be the duty of the Trustee hereunder to pay any taxes or insurance or make any other outlay for the purpose of maintaining the security hereof.

Said Trustee shall not be obligated to recognize any person as a holder or owner of any bond secured hereby until such owner or holder shall produce such bonds and deposit the same with this Trustee and shall indemnify said Trustee to its full satisfaction from any and all costs, expense, or any other reasonable disbursements for which it may become liable by reason of such recognition.

It is mutually agreed that there shall be no personal liability upon this Trustee or any of its officers or directors nor personally upon any of said Church Trustees for anything in connection with this instrument or the bonds, the payment of which it secures.

On the payment of all bonds secured hereby, the said Trustee will, at the expense of said Church Trustees, make, execute and record full release hereof.
