THIS INDENTURE, Made this 14th day of November, in the year of our Lord, one thousand nine hundred and thirty-eight between Second Missionary Baptist Church

WITNESSETH, That the said part y of the first part, in consideration of the sum of Three Hundred and no/100 DOLLARS, to it duly paid, the receipt of which is hereby acknowledged, has sold, and by this Indenture do Grant, Bargain, Sell and Mortgage to the said part y of the second part, the following described real estate situated and being in the County of Douglas and State of Kansas, to-wit:

And the said part y of the first part do hereby covenant and agree that at the delivery hereof the lawful owner of the premises above granted, and named of a good and indefeasible estate of inheritance therein, free and clear of all incumbrance

except a mortgage to The Lawrence Building and Loan Association in the sum of \$1500.00 and that they will warrant and defend the same against all parties making lawful claim thereto.

It is agreed between the parties hereto that the part y of the first part shall at all times during the life of this Indenture, pay all taxes or assessments that may be levied or assessed against said real estate when the same become due and payable, and that it keep the building upon said real estate insured against fire and tornado in such sum and by such insurance company as shall be specified and directed by the part y of the second part, the loan, if any, made payable to the part y of the second part to the extent of its interest. And in the event that said part y of the first part shall fail to pay such taxes when the same become due and payable and to keep said premises insured as herein provided, then the part y of the second part may pay said taxes and insurance, or either, and the amount so paid shall become a part of the indebtedness secured by this Indenture, and shall bear interest at the rate of 10% from the date of payment until fully repaid.
