THIS INDENTURE, Made this 22nd day of December, in the year of our Lord, one thousand nine hundred and thirty-eight, between Margaret S. Haines, a single woman,

of Lawrence in the County of Douglas and State of Kansas  
part y of the first part, and J. C. Porter, of Lawrence, Douglas County, Kan.

WITNESSETH, That the said part y of the first part, in consideration of the sum of Six thousand five hundred and no/100 DOLLARS, to her duly paid, the receipt of which is hereby acknowledged, he has sold, and by this indenture doth Grant, Bargain, Sell and Mortgage to the said part y of the second part, following described real estate situated and being in the County of Douglas and State of Kansas, to wit:

The North one-half ( $\frac{1}{2}$ ) of the Southwest one-quarter ( $\text{SW}^{\frac{1}{4}}$ ) and the Northwest one-quarter ( $\text{NW}^{\frac{1}{4}}$ ), less five acres in the Northwest Corner thereof conveyed to C.E. Daniels and described in deed of record in Deed Book number 119 on page 555, in the office of the Register of Deeds for Douglas County, Kansas, all in Section number Thirty-Three ( $\text{S33}$ ), Township Twelve (Twp 12), Range Nineteen (R 19), containing Two Hundred Thirty Five acres (235 a), more or less. According to the government survey

with the appurtenances and all the estate, title and interest of the said part y of the first part therein.  
And the said part y of the first part doth hereby covenant and agree that at the delivery hereof she is the legal owner of the premises above granted, and intend  
a good and indefeasible estate of inheritance thereof, free and clear of all incumbrance.

and that will warrant and defend the same against all parties making lawful claim thereto.

It is agreed between the parties hereto that the part Y of the first part shall at all times during the life of this indenture, pay all taxes or assessments that may be levied or assessed against real estate which the same becomes due and payable, and that the Z will keep the buildings upon real estate insured against fire and tornado in such sum and by such insurance company as shall be specified and directed by the part Y of the second part, the sum, if any, made payable to the part Y of the second part to the extent of Z interest. And in the event that the part Y of the first part shall fail to pay such taxes when the same become due and payable and to keep said premises insured as herein provided, that the part Y of the second part may pay said taxes and insurance, or either, and the amount so paid shall become a part of the amount, caused by this indenture, and shall bear interest at the rate of Y percent per annum.

THIS GRANT is intended as a mortgage to secure the payment of the sum of Six thousand five hundred and no/100 DOLLARS, \$15,38 according to the terms of one certain written obligation for the payment of said sum of money, executed on the 22<sup>nd</sup> day of December, 19<sup>th</sup> 19<sup>th</sup> by its terms made payable to the part y of the second part, or to discharge all interest accruing thereon according to the terms of said obligation and also to secure any sum or sums of money advanced by the said party y of the second part to pay for any insurance or to discharge any taxes with interest charged thereon.
