of the County of Douglas, and State of Kansas, hereinafter called the Mortgagor, whether one or more, and the Land Bank Commissioner, with offices in the City of Wichita, Kansas, acting pursuant to Part 3 of the act of Congress known as the Emergency Farm Mortgage Act of 1933, hereinafter called the Mortgage.

WITNESSETH: That said Mortgagor, for and in consideration of the sum of

ONE THOUSAND THREE HUNDRED AND NO/100 (\$1300.00) DOLLARS

in hand paid by the Mortgagee, receipt of which is hereby acknowledged, has granted, bargained and sold, and does by these presents grant, bargain, sell and convey to said Mortgagee, all of the following described real estate situate in the County of Douglas, and State of Kansas, to-wit:

The East half (E $\frac{1}{2}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section Twenty-six (26), Township Fourteen (14) South, Range Twenty (20) East of the Sixth (6th) Principal Meridian.

Containing in all 80 acres, more or less, according to U. S. Government survey thereof.

Together with all privileges, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, including all water, irrigation and drainage rights of every kind and description, however evidenced or manifested, and all rights of way, apparatus and fixtures belonging to or used in connection therewith, whether owned by the Mortgagor at the date of this mortgage, or thereafter acquired.

That said above granted premises are free and clear of all liens and encumbrances whatsoever, excepting A first mortgage to The Federal Land Bank of Wichita, in the sum of \$1100.00, dated October 1, 1934, filed for record on the 4th day of Dec. 1934 at 9:40 a.m., recorded in book 81, page 154, of the records in the office of the Register of Deeds of Douglas County, Kansas.

To make return of said real estate for taxation, when so required by law; to pay before they become delinquent all taxes, charges and assessments legally levied against the property hereby conveyed; and to receive and accept of all moneys received or certificates copies thereof, evidencing such payment.

To pay at all times during the existence of this mortgage all sums and interest on any mortgage, judgment, lien or encumbrance senior to the principal debt secured by this mortgage; to perform all covenants and conditions contained in any such mortgage, judgment, lien or encumbrance; to pay the principal debt secured by such mortgage, judgment, lien or encumbrance; to execute and deliver to the holder of any such mortgage, judgment, lien or encumbrance, copies thereof, evidencing such payment; and to perform all other covenants and conditions contained in any such mortgage, judgment, lien or encumbrance.
