WITNESSETH, That the said part y of the first part, in consideration of the sum of

Seven hundred and fifty DOLLARS
to him duly paid, the receipt of which is hereby acknowledged, he s sold and by these presents do es grant, bargain, sell and Mortgage to the said part y of the second part his heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas, and State of Kansas, described as follows, to-wit:

Beginning at the South line of; at eleven hundred and two (1102) feet West of the South East corner of the North half of the South West quarter of Section thirty six (36) in township twelve (12) South of range nineteen (19) east of the sixty P.M. thence West one hundred and thirty two (132) feet; thence North three hundred thirty (330) feet; thence one hundred thirty two (132) feet; thence South three hundred thirty (330) feet to the place of beginning, containing one acre, the South thirty three (33) feet being included in road number thirty five (35).

And the said party of the first part do es hereby covenant and agree that at the delivery hereof he is the lawful owner of the premises above granted, and seired of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances

This grant is intended as a mortgage to secure the payment of the sum of seven hundred and fifty Dollars, according to the terms of a certain mortgage-bond this day executed and delivered by the said party of the first part to the said part y of the second part

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payments, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said part y of the second part his executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sale to retain the amount then due for principal and interest, together with the cost and charges of making such sale, and the overplus, if any there be, shall be paid by the part y making such sale, on demand, to said party of the first part his heirs and assigns
