

DOUGLAS COUNTY

Fifth. The following described real estate situated in Labette County, Kansas:

Item 1. Lots Number Four (4), Five (5), Six (6), Seven (7) and Eight (8) in Block Number Eighty-nine (89) of the City of Parsons.

Item 2. Commencing at the Southwest corner of Lot Number Eight (8), Block Number Eighty-nine (89) of the City of Parsons, thence South Fifteen (15) feet; thence East Three Hundred and Fifty-five (355) feet to the West line of the right-of-way of the Kansas City and Pacific Railway; thence North along the West line of said right-of-way Fifteen (15) feet, more or less, to the South line of Block Number Eighty-nine (89); thence West along the South line of Block Number Eighty-nine (89) to the place of beginning, all in Section Nineteen (19), Township Thirty-one (31), Range Twenty (20).

Item 3. Commencing Fifteen (15) feet South of the Southwest corner of Lot Number Eight (8) in Block Number Eighty-nine (89) in the City of Parsons; thence South One Hundred (100) feet; thence East Three Hundred and Fifty-five (355) feet more or less, to the right-of-way of the K. C. & P. Railway; thence North along the West line of said right-of-way One Hundred (100) feet; thence West Three Hundred and Fifty-five (355) feet, more or less, to place of beginning, all in the Southwest quarter (SW $\frac{1}{4}$) Section Nineteen (19), Township Thirty-one (31), Range Twenty (20).

Item 4. Lots Twenty-five (25) and Twenty-six (26), Block Thirty-three (33), in the City of Parsons, together with all party wall agreements and rights thereunder.

Item 5. Lot One (1) and the West one-half of Lot Two (2), Block Three (3), South Side Addition to the City of Parsons.

Sixth. The following described real estate situated in Leavenworth County, Kansas:

Item 1. All the tract or parcel of land situate in the City of Leavenworth proper, as designated and described on the original map or plat of said city, commencing at the northeast corner of Block N, running thence West to the East line of Main Street; thence South on the said East line of said Main Street, One Hundred and Fifty (150) feet; thence East to the East line of said Block N; thence North on the East line of said block to the place of beginning, intending to convey a piece of ground in the Northeast corner of said Block N, One Hundred and Fifty (150) feet by One Hundred and Ten (110) feet.

Item 2. All that part and portion of Block N in the City of Leavenworth which lies between Main and Second Streets and South of Short Street.

Item 3. A part of the Northwest Quarter of Section Thirty-six (36), in Township Eight (8), Range Twenty-two (22) East, commencing at the Northwest corner of Block One (1) of Clark and Rees' Addition to Leavenworth City; thence in an Easterly direction along the North line of said Block One (1) Two Hundred and Sixty-five (265) feet to the West line of Main Street; thence Northerly on the West line of Main Street Eighteen and Eight-tenths (18.8) feet to the South line of Block N in Leavenworth City proper; thence West along the South line of Block N (City Proper), Two Hundred and Sixty-nine and Three tenths (269.3) feet to the East line of Second Street; thence Southerly along the East line of Second Street Sixty-six and One-half (66 $\frac{1}{2}$) feet to the place of beginning.

Item 4. Lots numbered Five (5) and Six (6) in Block numbered Eighty-two (82) in the City of Leavenworth (Proper), according to recorded plat of said city.

Item 5. Lot Thirty-three (33), in Block numbered Six (6), of Brine, Roelofson and Company's subdivision of the City of Leavenworth.

Item 6. The North Eighty-five (85) feet of the East One-half (E $\frac{1}{2}$) of Lot Twenty-seven (27), Block H, Rankin's Subdivision to Leavenworth City.

Item 7. Lot numbered One (1), in Block numbered Thirty-five (35) Leavenworth City (Proper)

Item 8. Lot Nine (9), Block Five (5), Rees Doniphan and Thornton's Addition to Leavenworth City, as per plat on file in Register of Deeds' Office for said county.

Item 9. Lot Four (4), Block Eighty-two (82) Leavenworth City Proper, as per plat on file in the Register of Deeds' Office for said county.

Item 10. All that tract or parcel of land situated in the County of Leavenworth, State of Kansas, described as follows, to-wit: Commencing at a point on the East line of Sixth Street One Hundred and Fifteen and Eight-tenths (115.8) feet South of the Northwest corner of Block J, Leavenworth City proper, thence running East One Hundred (100) feet parallel with the North line of Block "J"; thence South Sixty-seven and One-half (67 $\frac{1}{2}$) feet parallel with the East line of Sixth Street to the South line of City Proper; thence Westerly about One Hundred (100) feet on the South line of City Proper to the East line of Sixth Street; thence North Fifty and One-half (50 $\frac{1}{2}$) feet on said East line of Sixth Street to the place of beginning.

Item 11. All that tract or parcel of real estate described as follows, to-wit: Beginning at a gas pipe at the Southwest corner of Lot Number Four (4) in Block Number Eighty-two (82) Leavenworth City Proper; thence Southeasterly on the extension of the line between Lots Four (4) and Five (5) in said Block Eighty-two (82) One Hundred and Forty-two (142) feet more or less to a gas pipe on the South line of City Proper; thence Easterly on said South line Eight (8) feet to an iron bolt on the East line of the tract of land owned by Custer Post Number 6, G.A.R.; thence Southerly along said East line Sixty-two and Seven-tenths (62.7) feet more or less to an iron bolt; thence Easterly parallel with the South line of Block Eighty-two (82) City Proper, Forty and Seven-tenths (40.7) feet to an iron bolt; thence North Two Hundred and Five (205) feet more or less, to the Southeast corner of said Lot Four (4) in Block Eighty-two (82) thence Westerly along the South line of said Lot Four (4) Forty-eight and Seven-tenths (48.7) feet more or less to the place of beginning.

Item 14. Lots Numbered Seven (7) and Eight (8) in Block Numbered Eighty-two (82) in Leavenworth City Proper.

Item 15. Beginning at a point at the Northwest Corner of Lot Two (2) in Block "L", Callaghan, Smith & Hurd's Subdivision to the City of Leavenworth, thence running South along the East line of Fourth Street, One Hundred Sixty (160) feet to the center of the Arch of the Bridge over Three Mile Creek, thence Easterly along a line projected between the centers of the arches of the Bridges over Three Mile Creek at Third and Fourth Streets; to a point where said projected line intersects the West boundary line of the plot of ground owned by The Kansas Electric Power Company, and mentioned in certain deed recorded in Book 213, Page 391, of the records in the office of the Register of Deeds for Leavenworth County, Kansas, thence North along said West boundary line to the South line of Block Eighty-two (82), City Proper; thence in a Southwesterly direction along the East Boundary line of Lot One (1), in Block "L", Callaghan, Smith & Hurd's Sub-
