MORTGAGE

WITNESSETH, That the said party of the first part, in consideration of the sum of FIVE THOUSAND DOLLARS (\$5,000.00) to it duly paid, the receipt of which is hereby acknowledged, has sold and by these presents does grant, bargain, sell and Mortgage to the said party of the second part her heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows; to-wit:

All of Lots 1, 2, 11, and 12 in Babcock's Addition to the City of Lawrence, said

with all the appurtenances, and all the estate, title and interest of the party of the first part therein. And the said THE KAPPA ALPHA THETA BUILDING ASSOCIATION, Incorporated, does hereby covenant and agree that at the delivery hereof it is the lawful owner of the premises above granted; and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances except a mortgage of \$35,000.00 to J.C. Nichols and Herbert V. Jones, University Trustees under the Last Will of William Rockhill Nelson, deceased.

This grant is intended as a mortgage to secure the payment of the sum of Five Thousand Dollars according to the terms of one certain note this day executed and delivered by the said party of the first part, The Kappa Alpha Theta Building Association, Incorporated, to the said party of the second part, Mrs. Harriet E. Tanner, and this conveyance shall be void if such payment be made as herein specified. But if default be made in such payments or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part her executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sale to retain the amount then due for principal and interest, together with the cost and charges of making such sale, and the overplus, if any there be, shall be paid by the party making such sale, on demand, to said Mrs. Harriet E. Tanner, her heirs and assigns.
