INDENTURE OF RELEASE

THIS INDENTURE OF RELEASE, made this 29th day of December, 1938, by CENTRAL HANOVER BANK AND TRUST COMPANY (formerly Central Union Trust Company of New York), a corporation organized and existing under the laws of the State of New York, and COMMERCE TRUST COMPANY, a corporation organized and existing under the laws of the State of Missouri, as Trustees under the Mortgage and Indenture of Trust and Indenture supplemental thereto hereinafter mentioned,

WITNESSETH:

WHEREAS, Cities Service Gas Company, for the purpose of securing the payment of its First Mortgage Pipeline 5th Gold Bonds, did make, execute and deliver to Central Union Trust Company of New York, (now Central Hanover Bank and Trust Company) and Commerce Trust Company (Kansas City, Mo.), as Trustees, a certain Mortgage and Indenture of Trust dated as of May 1, 1927, which was duly filed for record in the following counties in the States of Kansas, Oklahoma and Missouri
