KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, Union Pacific Railroad Company (hereinafter called the Railroad Company) executed and delivered to The Equitable Trust Company of New York, a corporation duly organized and existing under and by virtue of the laws of the State of New York, a certain Indenture of Mortgage dated June 1, 1908, known as the Railroad Company's First Lien and Refunding Mortgage (hereinafter called the Mortgage), and Indentures Supplemental thereto dated October 15, 1908, June 28, 1909, April 22, 1910, October 26, 1914, January 14, 1915, June 1, 1923, April 2, 1925, and November 26, 1926 (hereinafter called the Supplemental Indentures) for the considerations therein mentioned and to secure the payment of an issue of bonds designated as the Railroad Company's First Lien and Refunding Mortgage Four Per Cent Bonds; and

WHEREAS, the Supplemental Indenture dated June 1, 1923, for the consideration therein mentioned secured the payment of an additional 1% interest on certain of said First Lien and Refunding Mortgage Four Per Cent Bonds; and

WHEREAS, on or about May 31, 1930, The Equitable Trust Company of New York was duly consolidated with The Chase National Bank of the City of New York, a national banking association (hereinafter sometimes called the Chase National Bank), by virtue of which merger and consolidation the Chase National Bank is now the duly qualified and acting successor to The Equitable Trust Company of New York, as Trustee under the Mortgage and the Supplemental Indentures; and

WHEREAS, the Mortgage and the Supplemental Indentures, as appear from recordation data in possession of the Chase National Bank were recorded as follows:
