## AGREEMENT FOR EXTENSION OF MORTGAGE

Topeka, Kansas, Nov. 1, 1940

The undersigned hereby covenant that they are the legal owners of the premises conveyed to The National Reserve Life Ins. Co. by a Mortgage, dated October 15 1930 made by Minnie Seale, a widow; Henry G. Seale & wife, Hulda; Mary Hunsinger & hsb., Geo. W.; Louise Schulmeyer & hsb. P. E., and duly recorded in Book 77, on page 175, in Douglas County, Kansas, to The National Reserve Life Ins. Co. which Mortgage was given to secure the payment of a note or bond for the sum of \$4,140.00, payable November 1, 1930 to The National Reserve Life Insurance Company or order, upon which note or bond there remains unpaid the sum of \$4,000.00, of principal money; and in consideration of the second extension of the time for the payment thereof for the term of five years from maturity of the first extension, hereby agrees to assume said indebtedness and to pay interest upon said principal sum, from the day whereon the same, by the terms of said note or bond, becomes due, at the rate of five per cent, per annum, payable semi-annually for and during said term of extension, according to the tenor and effect of the extension coupons hereto attached; both principal and interest to be paid, when due, at the Home Office of The National Reserve Life Ins. Co. Topeka, Kansas; and in case of default in payment of any of said extension coupons, or in case of non-payment of taxes or breach of any of the covenants contained in said mortgage, it shall be optional with the legal holder or holders of said principal note to declare said principal sum immediately due and payable.
