

County, Oklahoma, and a multiple river crossing consisting of 0.6 miles of 10" pipe; also a 2" lateral extending from the above described line to Wann in Nowata County, Oklahoma, said line totaling 1.2 miles of 2" pipe in Nowata County, Oklahoma;

Thence continuing east through Craig County, Oklahoma, with a single 16" line to the Ottawa County, Oklahoma line, said line totaling 24.0 miles of 16" pipe in Craig County, Oklahoma; also a 6" lateral extending from the above described line to Vinita in Craig County, Oklahoma, serving also Welch and Blue Jacket in Craig County, Oklahoma; said lateral totaling 18.8 miles of 6" pipe in Craig County, Oklahoma;

Thence continuing with a single 16" line through Ottawa County, Oklahoma to the Oklahoma-Kansas State line, said line totaling 21.4 miles of 16" pipe, and two multiple river crossings consisting of 0.6 miles of 10" pipe in Ottawa County, Oklahoma; also, short lateral lines from the above described line serving Miami, Commerce, Picher, Gardin, Quapaw, and various mining properties in Ottawa County, Oklahoma, said laterals totaling approximately 1.6 miles of 10" pipe, 2.1 miles of 8" pipe, 9.9 miles of 6" pipe, 0.3 miles of 5" pipe, 4.9 miles of 4" pipe, 2.2 miles of 3" pipe, and 0.7 miles of 2" pipe, all in Ottawa County, Oklahoma;

Also, a 4" lateral from the above described main line to Baxter Springs in Cherokee County, Kansas, said line totaling 2.2 miles of 4" pipe in Ottawa County, Oklahoma, and 0.8 miles of 4" pipe in Cherokee County, Kansas; also, a 12" line from the above described main line to the Riverton Power Plan of the Empire District Electric Company at Riverton in Cherokee County, Kansas, said line totaling 1.2 miles of 12" pipe in Ottawa County, Oklahoma, and 5.3 miles of 12" pipe and 1.1 miles of 6" pipe in Cherokee County, Kansas;

Thence continuing east through Cherokee County, Kansas, with a single 16" line to the Kansas-Missouri State line, said line totaling 1.0 miles of 16" pipe in Cherokee County, Kansas;

Thence continuing in an easterly direction through Newton County, Missouri with a single 16" line to the Saginaw compressor Station in Section 36, T. 27 N, R. 33 W, Newton County, Missouri; thence continuing with a single 10" line to the Lawrence County line, said line totaling 8.0 miles of 16" pipe and 23.3 miles of 10" pipe, and a multiple river crossing consisting of 0.2 miles of 10" pipe, all in Newton County, Missouri;
