Thence continuing northeast in Montgomery County, Kansas, with a single 18" line to the Grabham Compres-sor Station in Section 27, T. 33 S., R. 15 E., Montgomery County, Kansas; thence continuing in a northerly direction with two 16" lines to the Wilson County, Kansas line, said line totaling 13.2 miles of 18" pipe, and 39.1 miles of 16" pipe, in Montgomery County, Kansas;

Also an S" line extending from the above mentioned Grabham Compressor Station north to Independence in Montgomery County, Kansas, with short field lines, said lines totaling approximately 3.3 miles of 8" pipe, 1.8 miles of 6" pipe, 4.3 miles of 2" pipe; also an 8" lateral extending from the above mentioned 16" line 1.3 miles in a northwesterly direction to Atlas Portland Cement Plant in Sec. 32, T. 32 S., R. 16 E., in Montgomery County, Kansas; also a 6" lateral serving the town of Cherryvale in Montgomery County, Kansas, said line totaling 3.3 miles of 6" pipe and 0.1 miles of 3" pipe; and also a lateral extending south and east from the above mentioned 18" and consisting of 2.1 miles of 2" pipe, in Montgomery County, Kansas;

Thence continuing in a northerly direction through Wilson County, Kansas, with two 16" lines passing the Thaver Compressor Station in Sec. 21, T. 29 S., R. 17 E., Wilson County, Kansas, passing Petrolia Junction in Sec. 11, T. 28 S., R. 16 E., Wilson county, Kansas, and continuing to the Neosho county, Kansas line, said line totaling 48.7 miles of 16" pipe in Wilson county. Kansas:

Also an 8" lateral extending east from the main line near the south line of Wilson county, Kansas, extending east into Neosho county, Kansas to a point north of Dennis in Labette County, Kansas; thence south with the 8" line to Dennis, Labette county, Kansas; thence east with the S" line to a point near Parsons in Labette county, Kansas; thence northeast into Neosho county, Kansas, with a 6" line serving South Mound and continuing east and north with a 6" line passing the St. Paul Compressor Station in Sec. 36, T. 29 S., R. 20 E., and continuing to an end in Section 19, T. 29 S., R. 21 E., Neosho county, Kansas, said lateral with branches totaling 2.0 miles of 8" pipe in Wilson county, Kansas, 8.0 miles of 8" pipe, 11.5 miles of 6" pipe in Neosho county, Kansas; and 10.2 miles of 8" pipe and 1.4 miles of 6" pipe in Labette county, Kansas; Also an 8" lateral extending west from the above
