totaling approximately 8.5 miles of 20" pipe, 11.4 miles of 8" pipe, 11.0 miles of 6" pipe, 5.5 miles of 4" pipe, and 1.10 miles of 3" pipe in Gray County, Texas;

Thence continuing in a westerly direction to Sec. 3, H. & G. N. survey near Deall, Carson County, Texas, said line with its field gathering lines and laterials totaling approximately 16.7 miles of 20" pipe, 13.2 miles of 16" pipe, 6.5 miles of 12" pipe, 23.1 miles of 8" pipe, 27.7 miles of 6" pipe, 12.7 miles of 4" pipe, 2.0 miles of 3" pipe, and 3.0 miles of 2" pipe, all in Carson County, Texas.

WICHITA COMPRESSOR STATION TO OTTAWA COMPRESSOR STATION.

A combination 18" and 20" pipeline extending from the Wichita Compressor Station in Sec. 17, T. 28 S., R. 1 E., Sedgwick Connty, Kansas, northeasterly to the Ottawa Compressor Station in Sec. 32, T. 16 S., R. 20 F., Franklin County, Kansas, and passing through the counties of Sedgwick, Butler, Chase, Greenwood, Lyon, Coffey, Osage and Franklin, Kansas, said system being more specifically described as follows:

Beginning at the Wichita compressor station in Sec. 17, T. 28 S., R. 1 E. Sedgwick County, Kansas, and running in an east and northeasterly direction to the Butter County line, said line totaling 4.3 miles of 20" pipe, 7.3 miles of 12" pipe, and a multiple river crossing of 2.1 miles of 12" pipe in Sedgwick County, Kansas;

Also a lateral line extending from the above line north to the Greenwich field in Sec. 10, T. 26 S., R. 2 E., said line totaling 8.5 miles of 4" pipe, all in Sedgwick County, Kansas;

Also a lateral line extending from the above line north and west to Sec. 1, T. 28 S., R. 1 E., said line totaling 1.0 mile of 3" pipe and 1.5 miles of 2" pipe, all in Sedgwick County, Kansas;

Thence continuing in a northeasterly direction passing Eldorndo in Butler County to the Chase County line, said line totaling 40.0 miles of 20" pipe, and a multiple river crossing of 3.2 miles of 12" pipe, and 2.2 miles of 16" pipe; Also a lateral line running west from the above line

Also a lateral line running west from the above line to Towanda and Benton, said line totaling S.1 miles of 2" pipe in Butler County, Kansas;

Thence continuing in a northeasterly direction passing Matfield Compressor Station in Sec. 28, T. 22 S.,
