miles of 6" pipe in Rice County, Kansas; 1.5 miles of 2" pipe, 10.1 miles of 3" pipe, 4.5 miles of 4" pipe, 1.0 mile of 5" pipe, 5.8 miles of 6" pipe, in Barton County, Kansas; 1.0 mile of 2" pipe and 0.5 miles of 6" pipe in Stafford County, Kansas;

Also a combination gathering and sales system extending enstward to the Lyons field, said line totaling 0.8 miles of 8" pipe, and 0.7 miles of 6" pipe, with a lateral to the American Salt Company and a water pump station, and a tie-over to the Hutchinson-Superior 8", said lateral totaling 1.4 miles of 4" pipe, 0.5 miles of 6" pipe, 0.8 miles of 2" pipe, and 0.3 miles of 5" pipe, and 0.5 miles of 4" to the Western Salt Company, all in Rice County, Kansas;

Also fuel sales system extending into the Genesee field, said lines totaling 0.5 miles of 2" pipe, 6.2 miles of 3" pipe, 6.8 miles of 4" pipe, and 1.0 mile of 5" pipe, in Rice County, Kansas;

Also a fuel sales system extending into the Lorrain field in Rice and Ellsworth Counties, said line totaling 0.5 miles of 2" pipe, 2.3 miles of 3" pipe, 0.7 miles of 4" pipe, 3.5 miles of 5" pipe, and 7.0 miles of 6" pipe in Rice County, Kansas; 1.5 miles of 3" pipe, and 7.5 miles of 4" pipe in Ellsworth County, Kansas;

Also a line extending to Geneseo town border in Ellsworth County, Kansas, said line totaling 1.2 miles of 2" pipe in Ellsworth County, Kansas.

Thence continuing north with a single S" line through Ellsworth County, Kansas to the Lincoln County line, said line totaling 24.2 miles of 8" pipe, in Ellsworth County, Kansas;

Also with a lateral extending to the town of Kanopolis with an extension to the Independent Salt Company, said line totaling 1.7 miles of 4" pipe and 1.6 miles of 3" pipe in Ellsworth County, Kansas;

Also a lateral extending to the town of Ellsworth in Ellsworth County, Kansas, said line totaling 1.3 miles of 4" pipe in Ellsworth County, Kansas;

Thence continuing north with a single 8" line through Lincoln County, Kansas, to the Mitchell County line, said line totaling 24.2 miles of 8" pipe in Lincoln County, Kansas.

Also a lateral extending to the towns of Lucas and Lucay, in Russell County, Kansas, and serving the towns of Vesper and Sylvan Grove in Lincoln County, Kansas, said pipeline totaling 11.2 miles of 3" pipe, and 6.4 miles of 2" pipe, in Lincoln County, Kansas;
