EXTENSION AGREEMENT

Whereas, the Trustees of the First Methodist Episcopal Church of Baldwin, Kansas, conveyed to The First National Bank of Lawrence, Kansas, by Trust Deed dated September 1, 1931, and recorded in Book 77 at page 346 certain lots located in Baldwin City, Kansas, as security for a bond issue totalling \$40,000.00, said security to be held in trust by said First National Bank of Lawrence, Kansas, for the benefit of any and all bond holders on which it is hereby acknowledged there is now due and unpaid the sum of \$14,000.00, and
