(g) That certain gas franchise No. 45, issued January 23, 1930, by the city of Ramona, in the county of Marion, state of Kansas, to C. A. Nicoll, his successors and assigns, and now owned by the company, and all renewals or extensions of said franchise, or any other or new gas franchises hereafter granted to the company by said city of Ramona.

(h) That certain gas franchise No. 74, issued January 6, 1930, by the city of Tampa, in the county of Marion, state of Kansas, to C. A. Nicoll, his successors and assigns, and now owned by the company, and all renewals or extensions of said franchise, or any other or new franchises hereafter granted to the company by said city of Tampa.

VIII.

IN THE COUNTY OF MORRIS, STATE OF KANSAS:

1.

All transmission, distribution and gathering lines as follows:

(a) Council Grove transmission line consisting of 7.5456 miles of 5 inch pipe extending from the southeast corner of Section 10, Township 16S, Range 7E, thence easterly along the south lines of Sections 11 and 12, Township 16S, Range 7E, Sections 7, 8, 9 and 10, Township 16S, Range 6E to the western limits of Council Grove, Kansas, all as shown on a map; and

(b) Herington transmission line consisting of 14.8231 miles of 6 inch pipe extending from the southeast corner of Section 10, Township 16S, Range 7E, thence westerly along the south lines of Sections 10, 9, 8 and 7 in Township 16S, Range 7E, Sections 12, 11, 10, 9, 8 and 7, Township 16S, Range 6E and Sections 12, 11, 10, 9, 8 and 7, Township 16S, Range 6E to the west county line of Morris County, Kansas, all as shown on a map; and

(c) South Field transmission line consisting of 6.6436 miles of 5 inch pipe extending from the southeast corner of Section 10, Township 16S, Range 7E, thence southerly along the east lines of Sections 16, 22, 27 and 34, Township 16S, Range 7E, and Sections 3, 10 and 15, Township 17S, Range 7E, to the South Field Compressor Station No. 2, situated in the southeast corner of Section 16, Township 17S, Range 7E, all as shown on a map; and

(d) White City transmission line consisting of 8.8306 miles of 3 inch pipe extending from the southwest corner of Section 12, Township 16S, Range 6E, thence northerly along the west lines of Sections 12 and 1, Township 16S, Range 6E, and the east lines of Sections 35, 26 and 25, Township 16S, Range 6E, and the west lines of Sections 13, 12 and 1, Township 16S, Range 6E, thence across the intersection of Sections 1 and 2 of Township 16S, Range 6E and Sections 35 and 36 of Township 14S, Range 6E, thence northwesterly through Section 35, Township 14S, Range 6E to the southern limits of White City, Kansas, all as shown on a map; and

(e) Wilsey transmission line consisting of 2.0116 miles of 2 inch pipe extending from the southwest corner of Section 16, Township 16S, Range 7E, thence southerly along the west lines of Sections 16 and 21 in Township 16S, Range 7E, to the northeast corner of Section 16 in Township 16S, Range 7E, at the eastern limits of Wilsey, Kansas, all as shown on a map; and

(f) Delavan transmission line consisting of 3.5453 of a mile of 2 inch pipe extending from the south line of Section 7, Township 16S, Range 6E, thence southerly across Section 15, Township 16S, Range 6E, to the northern limits of Delavan, Kansas, all as shown on a map; and

(g) White City distribution system consisting of 5.1172 miles of 2 inch, 0.2299 of a mile of 3 inch and 0.8684 of a mile of 4 inch pipe situated within the corporate limits of White City, Kansas, Township 14S, Range 6E, and

(h) Wilsey distribution system consisting of 0.1508 of a mile of 1½ inch, 2.8668 miles of 2 inch, 0.0773 of a mile of 3 inch and 0.3270 of a mile of 4 inch pipe situated within the corporate limits of Wilsey, Kansas, Township 16S, Range 7E; and

(i) Delavan distribution system consisting of 0.8087 of a mile of 2 inch pipe situated in Delavan, Kansas, Township 16S, Range 6E; and

(j) South Field gathering lines consisting of 0.0826 of a mile of 1 inch, 3.3669 miles of 2 inch, 0.7458 of a mile of 3 inch, 2.1246 miles of 4 inch and 0.4341 of a mile of 5 inch pipe connecting gas wells situated in Section 14, 15, 16, 22, 23 and 27, Township 17S, Range 7E; and

(k) North Field gathering lines consisting of 1.4356 miles of 2 inch, 0.1250 of a mile of 3 inch, 2.0747 miles of 4 inch and 0.5500 of a mile of 6 inch pipe connecting gas wells situated in Sections 14, 15, 22 and 23, Township 16S, Range 7E; together with all border and field measuring stations including houses, lease house, meters, regulators, equipment, pipe and fittings, well equipment; also service pipe, meters, regulators and meter connections in service, easements and right-of-ways appertaining thereto or a part thereof, now owned or at any time hereafter acquired.

2.

All compressor stations as follows:

(a) Two Ingersoll-Rand compressors with one 25 horse-power Waukesha engine and one 65 horse-power engine together with houses, gauges, regulators, miscellaneous valves, pipe and fittings situated in Section 14, Township 16S, Range 7E.

(b) One Ingersoll-Rand compressor with one 65 horse-power engine together with house, gauges, regulators, miscellaneous valves, pipe and fittings situated in Section 15, Township 17S, Range 7E.

3.

Nicoll, his successors and assigns, and now owned by the company, and all renewals or extensions of said franchise, or any other or new gas franchises hereafter granted to the company by said city of White City.

(b) That certain gas franchise No. 100, issued November 18, 1940 by the city of Wilsey, in the county of Morris, state of Kansas, to The Central West Utility Company, its successors and assigns, and now owned by the company, and all renewals or extensions of said franchise, or any other or new gas franchises hereafter granted to the company by said city of Wilsey.

(c) By and between A. T. Swan and Louise Swan, his wife, and C. A. Nicoll, dated May 31, 1930, covering the southwest quarter (SW_{1/4}) of Section 14, Township 17S, Range 7E, containing 160 acres, more or less, Morris County, Kansas, recorded in book H, page 121; and

(d) By and between W. H. Irwin and Rosa L. Irwin, his wife, and C. A. Nicoll, dated May 22, 1930, covering the southwest quarter of Section 15 and part of the southwest quarter of the northwest quarter of Section 15, Township 17S, Range 7E and containing 162 acres, more or less, Morris County, Kansas, recorded in book H, page 120; and

(e) By and between A. G. Alexander and Mary A. Alexander, his wife, and C. A. Nicoll, dated May 2, 1930, covering all of the northeast quarter (NE_{1/4}) of Section 22, Township 17S, Range 7E, containing 160 acres, more or less, Morris County, Kansas, recorded in book H, page 116; and

(f) By and between D. A. Wild and Sadie L. Wild, his wife, and the Arrow Oil & Gas Company, dated March 10, 1930, covering the southeast quarter of Section 15, Township 17S, Range 7E, containing 160 acres more or less, Morris County, Kansas, recorded in book H, page 152; together with all equipment in the Metcalfe No. 2 and 4 gas wells, Swan No. 1 gas well, Irwin No. 1 gas well, Alexander No. 1 gas well and Wild gas wells No. 1, 2 and 4 located on the above-described property.
