DISCHARGE OF MORTGAGE

THIS CERTIFIES, That a certain mortgage executed By Roy L. Sanford and Ethel B. Sanford, husband and wife, of County of Garfield, State of Oklahoma, mortgagors to Bartlett Mortgage Company of St. Joseph Buchanan County Missouri mortgagee, and by them assigned to the National Life Insurance Company (a corporation organized under the laws of Vermont, of Montpelier, in the County of Washington, in said State) dated the 29th day of June A.D. 1940 upon the following described property situated in the County of Douglas State of Kansas:
