WHEREAS under the terms of said Indenture First Mortgage Bonds (due 1947-1954), in the principal amount of Four Million Two Hundred Fifty Thousand Dollars (\$4,250,000) were uncanceled and outstanding immediately preceding the execution and delivery of this Deed of Release; and

WHEREAS sufficient funds have been deposited by The Gas Service Company with The Commercial National Bank and Trust Company of New York, as Trustee as aforesaid, for the redemption of all said bonds outstanding under said Indenture as therein provided; and

WHEREAS The Gas Service Company has complied with the provisions of said Indenture with respect to the release and satisfaction thereof and the Trustees have the power, at the request of The Gas Service Company, to execute a release and satisfaction of the aforesaid Indenture and said Trustees have been so requested;

Now, THEREFORE, The Commercial National Bank and Trust Company of New York and Commerce Trust Company, as Trustees as
