According to the terms of one certain written obligation for the payment of said sum of money, executed on the 21st day of February 19 47, and by its terms made payable to the part 1 of the second part, with all interest accruing thereon according to the terms of said obligation and also to secure any sum or sums of money advanced by the said part 1 of the second part to pay for any insurance or to discharge any taxes with interest thereon as herein provided, in the event that said part 2 of the first part shall fail to pay the same as provided in this indenture. 1

And this conveyance shall be void of such payments be made as herein specified, and the obligation contained therein fully discharged. If default be made in such payments on any part thereof or any obligation created thereby, or interest thereon, or if the taxes on said real estate are not paid when the same become due and payable, or if the insurance is not kept up, as provided herein, or if the buildings on said real estate are not kept in as good repair as they are now, or if waste is committed on said premises, then this conveyance shall become absolute and the whole sum remaining unpaid, and all of the obligations provided in this deed shall become due and payable, and the said premises shall be sold by the said trustee, or his assigns, at public or private sale, to the highest bidder for cash, without notice, and it shall be lawful for the said party of the second part, or his assigns, to take possession of the said premises and all the improvements thereon in the manner provided by law and to have a receiver appointed to collect the rents and benefits accruing therefrom; and to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all moneys arising from such sale to return the amount then unpaid of principal and interest, together with the costs and charges incident thereto, and the surplus, if any there be, shall be paid by the said party of the second part, or his assigns, to the said party of the first part, or his assigns.
