

THIS GRANT is intended as a mortgage to secure the payment of the sum of Three thousand and no/100

of the holder hereof, without notice, and it shall be lawful for the said party to whom this instrument is given, shall immediately mature and become due and payable at the option of  
the said payee and all the improvements thereon in the manner provided by law, and to have and to hold the same appurtenant to the land and  
therefrom; and to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, and the cost of all expenses from such sale to retain
