KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, The Kansas Electric Power Company, a corporation organized and existing under the laws of the State of Kansas (hereinafter called "Company"), on or about December 1, 1936, made, executed, acknowledged, and delivered to Bankers Trust Company and R. Gregory Page, as Trustee, a certain Indenture dated December 1, 1936, to secure the First Mortgage Bonds of said Company issued and to be issued thereunder, which said Indenture was duly filed for record in the office of the Register of Deeds of Douglas County, Kansas, on December 21, 1936, as a Real Estate Mortgage in Book 83 at Page 33; and

WHEREAS, pursuant to the terms of that certain Supplemental Indenture made as of the 28th day of December, A. D. 1936, by and between said The Kansas Electric Power Company, said Bankers Trust Company, as Trustee, and said R. Gregory Page, as Trustee, and Harris Trust and Savings Bank, a corporation organized and existing under the laws of the State of Illinois (hereinafter referred to as the "Successor Trustee") and Harold Eckhart, of Evanston, Illinois (hereinafter sometimes referred to as the "Successor Cotrustee") (the Successor Trustee and the Successor Cotrustee being hereinafter sometimes referred to as "Successor Trustee"), Bankers Trust Company and R. Gregory Page resigned as Trustees and Harris Trust and Savings Bank and Harold Eckhart were duly appointed Successor Trustees, which said Supplemental Indenture was filed for record in the office of the Register of Deeds of Douglas County, Kansas, on March 9, 1937, in Book 83 of Real Estate Mortgages, Page 112, to which said Indenture and said Supplemental Indenture and the record thereof as aforesaid reference is hereby made; and

WHEREAS, The Kansas Electric Power Company has sold certain hereinafter described property which is subject to the lien of the aforesaid Indenture and Supplemental Indenture and has requested the release of said property from the lien thereof:

NOW, THEREFORE, in consideration of the premises and of the sum of One Dollar (\$1.00) to the undersigned, Harris Trust and Savings Bank, and Harold Eckhart, as Trustees, paid, receipt whereof is hereby acknowledged, and pursuant to the request of the company, the undersigned, as Trustees as aforesaid, have remised, released and quitclaimed, and do hereby remise, release and quitclaim unto said The Kansas Electric Power Company and to its successors and assigns, all right, title, interest, claim and demand which the undersigned, as Trustees as aforesaid, may have acquired under or by virtue of said Indenture and said Supplemental Indenture in and to certain property situated in the City of Lawrence, Douglas County, State of Kansas, described as follows, to wit:

Lot Number One Hundred Twenty-one (121)
 in Fairfax, an addition to the City of
 Lawrence;

And

All the right, title and interest
 of the Company in and to the following-
 described tract: Beginning at a point
 Thirty-five and Two-tenths (35.2) feet
 South of the Northwest corner of Lot "E"
