WHEREAS, said note is now held and owned by said Traders Gate City National Bank of Kansag City, and said note is presented and exhibited herewith, and,

WHEREAS, Kernie W. Binyon and Hilds N. Binyon are acquiring ownership interest in said premises, subject to the aforesaid mortgage, and it is desired that Benny Weldom Wolfe and Brorts Mae Wolfe be released from personal liability for payment. of said indebtedness and that Kernie W. Binyon and Hilds N. Binyon shall assume all liability for the payment of said indebtedness, and the Traders Gate City National Bank of Kansas City shall look to Kernie W. Binyon and Hilds N. Binyon for payment.

NOW, THEREPORE, in consideration of the premises and the sum of One Dollar (\$1.00) each to the other in hand paid, receipt of which is by each of them hereby subject to said mortgage, to Kernie W. Binyon and Hilda N. Binyon, and the assumption by Kernie W. Binyon and Hilda N. Binyon of the unpaid balance of the aforesaid indebtedness, it is agreed and by these presents Kernie W. Binyon and Hilda N. Binyon do hereby assume and agree to pay the unpaid balance of the aforesaid inaccordance with the terms and provisions of said note, and to faithfully perform sideration therefor Traders Gate City National Bank of Kanmas City agrees that Benny Weldon Wolfe and Norts Mae Wolfe be and they are hereby released from personal liability for the payment of such indebtedness, so that Kernie W. Binyon and Hilda Y. Binyon shall be and are hereby substituted in the place and stead of Benny Weldon Wolfe and Reveta Mae Wolfe with respect to such indebtedness, with like effect as though Kernie W. Binyon and Hilda N. Binyon were the original makers of the note

It is further agreed that the assumption by Kernie ". Binyon and Hilds N. Binyon of said indebtedness shall be recited by appropriate words in the deed of conveyance whereby said land is conveyed to Kernie W. Binyon and Hilds N. Binyon.

Excepting as herein expressly provided said note and mortgage shall be and remain unaltered and in full-force and effect.
