This mortgage is given to secure the payment of the principal sum of - -- - Sixty-six Hundred and no/100 - - - - Dollars (\$ 6600.00). as evidenced by a certain promis-sory note of even date herewith, the terms of which are incorporated herein by reference, payable with interest at the rate of Four and one-half-per centum' (\$ fr \$) per annum on the unglid balance until paid, principal and interest to be paid at the office of - CKPITOL, FEDERAL-SAVINGS AND LOAN. ASSOCIATION in Topoka, KAnsas at such other place as the holder of the note may designate in writing, in monthly installments of .

commencing on the first day of Hovembor ,19 49 , and on the first day of each month thereafter, commencing on the first day of hovember 19 49, and on the first day of each month thereafter, until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of october 19 74. The Mortgagor covenants and agrees as follows :

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or note, at the times and in the manner therein provided. 2. That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee until the said note is fully paid, the following sums:

(a) If this mortgage and the note secured hereby are insured under the provisions of the National Housing Act and so long as they continue to be so insured, one-twelfth (1/12) of the annual mortgage insurance premium for the purpose of putting the Mortgagee in funds with which to discharge the said Mortgagee's obligation to the Federal Housing Commissioner for mortgage insurance premiums pursuant to the applicable provisions of the National Hous Act, as amended, and Regulations thereunder. The Mortgagee shall, on the termination of its obligation to pay mortgage insurance) premiums, credit to the account of the Mortgager all payments made under the provisions of this subsection which the Mortgagee has not become obligated to pay to the Federal Housing Commissioner.

The Mortgagee may collect a "late charge" not to exceed two cents (24) for each dollar (\$1) of each payment more than fifteen (15) days in arrears to cover the extra expense involved in handling delinquent payments.

3. That if the total of the payments made by the Mortgagor under (b) of paragraph 1 preceding shall exceed the amount of payments actually made by the Mortgagee for ground rents, taxes and assessments or insurance premiums, as the case may be, such excess shall be credited by the Mortgagee on subsequent ints of the same nature to be made by the Mortgagor.
