2. That, together with, and in addition to, the monthly payments of principal and interest payable er the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee until the said note is fully paid, the following sums:

(a) If this mortgage and the note secured hereby are insured under the provisions of the National Housing Act and so long as they continue to be so insured, one-twelfth  $(N_{22})$  of the annual Housing Act and so long as they continue to be so insured, one-tweithn (y<sub>2</sub>) of the annual mortgage insurance premium for the purpose of putting the Mortgagee in funds with which to discharge the said Mortgagee's obligation to the Federal Housing Commissioner for mort-gage insurance premiums pursuant to the applicable provisions of the National Housing Act, as amended, and Regulations thereunder. The Mortgagee shall, on the termination of the obligation to pay mortgage insurance premiums, credit to the account of the Mortgagor all payments made under the provisions of this subsection which the Mortgagee has not become obligated to pay to the Federal Housing Commissioner.

(b) A sum equal to the ground rents if any and the taxes and special assessments next due on the premises covered by this mortgage, plus the premiums that will next become due and pay-able on policies of fire and other hazard insurance on the premises covered hereby (all as and on ponces to interact other matrix insurance on the premises covered nervey (an as estimated by the Mortgagee) less all sums already paid therefor divided by the number of months to elapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes and special assessments, before the same become delinquent.

Any deficiency in the amount of such aggregate monthly payment shall, unless made good by the Morigagor prior to the due date of the next such payment, constitute an event of default under this morigage. The Morigagee may collect a "late charge" not to exceed two cents (24) for each dollar (41) of each payment more than fifteen (15) days in arrears to cover the extra expense involved in handling delinquent payments.

8.
