PARTIAL RELEASE OF LIEN OF TRUST INDENTURE
DATED JULY 1, 1939 and INDENTURES SUPPLEMENTAL THERETO, of
THE KANSAS POWER AND LIGHT COMPANY

KNOW ALL MEN BY THESE PRESENTS:

THAT THE KANSAS POWER AND LIGHT COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Kansas and having its principal office in the City of Topeka, Kansas (hereinafter called "Company"), on or about July 1, 1939, made, executed, acknowledged and delivered to Harris Trust and Savings Bank, a corporation organized and existing under the laws of the State of Illinois and having its principal office and place of business in the City of Chicago, Illinois, as trustee, a certain Mortgage Bonds of Company, issued and to be issued hereunder, which said Indenture was filed for record in the Office of the Register of Deeds of Douglas County, Kansas, on November 17, 1949, as a real estate mortgage in Book 97 at Page 1, and as a Chattel Mortgage as No. 4731, as amended and supplemented by a Supplemental Indenture dated April 1, 1949, filed and recorded in the Office of said Register of Deeds as a real estate mortgage in Book 97 at Page 2, and as a Chattel Mortgage as No. 4732, on November 17, 1949, and Supplemental Indenture dated October 1, 1949, filed and recorded in the Office of said Register of Deeds as a real estate mortgage in Book 97 at Page 3, and as a Chattel Mortgage as No. 4733, on November 17, 1949, and Supplemental Indenture dated December 1, 1949, filed and recorded in the Office of said Register of Deeds as a real estate mortgage in Book 97 at Page 4, and as a Chattel Mortgage as No. 4734, on November 17, 1949, and Supplemental Indenture dated January 6, 1950, to which Indentures and the record thereof as aforesaid reference is hereby made; and

THAT said Company has sold the property hereinafter described and has complied with the requirements of said Indenture and is entitled to the release of said property from the lien thereof.

NOW, THEREFORE, in consideration of the receipt and of the sum of One Dollar (\$1.00) to the undersigned, Harris Trust and Savings Bank, Trustee, said receipt of which is hereby acknowledged, and pursuant to the request of Company, the undersigned, as Trustee as aforesaid, has revised, released, and quitclaimed to said Company and to its successors and assigns, all right, title, interest, claim and demand which the undersigned, as Trustee as aforesaid, may have acquired under and by virtue of said Indenture, and any Indenture supplemental thereto, in and to the said real estate situated in Douglas County, State of Kansas, described as follows, to-wit:

Lots Numbers Eleven (11), Twelve (12), Twenty-three (23) and Twenty-four (24), in Block Sixteen (16), Babcock's Enlarged Addition to the City of Lawrence;
