5; That he will keep the premises above conveyed in as good order and condition as they are now<sub>g</sub> and will not commit or permit any waste thereof, reasonable wear and teaf excepted.

6. That the Mortgagor will keep the improventents now existing or hereafter erected on the mortraged premises, insured as may be required from time to time by the Mortgagee against loss by fire and other hazards, caualities and contingencies in such amounts and for such periods as it may require and will pay promptly, when due, any premiums on such insurance provision for payment of which has not been made hereinbefore.
