KANSAS RESIDENCE MORTGAGE

THIS MORTGAGE, Made the Twenty-fourth day of May A. D. 1951 between Wayne R. Harris and Helen M. Harris, individually and as husband and wife, of the County of Douglas, State of Kansas, hereinafter (whether one or more in number) called Mortgagors, and The Northwestern Mutual Life Insurance Company, a Wisconsin corporation, having its principal place of business at Milwaukee, Wisconsin, hereinafter called Mortgagee:

WITNESSETH, That Mortgagors, in consideration of the sum of Four thousand eight hundred dollars

to them in hand paid by Mortgagee, the receipt whereof is hereby acknowledged, do by these presents mortgage and warrant unto Mortgagee the following described Real Estate in the

County of Douglas and State of Kansas, to-wit:  
Lot five in block seven in Haskell Place, an addition to the city of Lawrence, in

Douglas County, Kansas, subject to reservations, restrictions, covenants, and easements of record, if any.

The proceeds of the loan hereby secured are being applied on the purchase price of the premises above described.

#### ARTICLE II. COVENANTS

Together with all buildings and improvements now or hereafter erected thereon and the rents, issues and profits thereof, and all sewers, drains, shades, storm sash and blinds, and heating, lighting, plumbing, gas, electric, ventilating, refrigerating and air-conditioning equipment used in connection therewith, all of which, for the purpose of this mortgage, shall be deemed fixtures and subject to the lien hereof, and the hereditaments and appurtenances pertaining to the property above described, all of which is referred to hereinafter as the "premises"

TO HAVE AND TO HOLD the same unto Mortgagee forever.

CONDITIONED, HOWEVER, That if Mortgagors shall pay or cause to be paid to Mortgagee, at its office in the City of Milwaukee, Wisconsin, the principal sum of Four thousand eight hundred dollars -

with interest at the rate of five per cent per annum until maturity, payable in installments of Forty-four and forty one-hundredths dollars -

on the Twenty-fourth day of August, 1951, and of each month thereafter, and the entire balance of principal and interest on July 24, 1963.

According to the terms of a promissory note of even date herewith executed by Mortgagors and payable to the order of Mortgagee, and shall likewise pay or cause to be paid such additional sums, with interest thereon, as may hereafter be loaned by Mortgagee to Mortgagors when evidenced by a promissory note or notes of Mortgagee, such additional note or notes to be identified by recital that it or they are secured by this mortgage, and such note or notes shall be included in the word "note" wherever it appears in the context of this mortgage, and shall also fully perform all the covenants, conditions and terms of this mortgage, then these presents shall be void, otherwise to remain in full force and effect.
