Together with the hereditaments and appurtenances to the same belonging or in any wise appertaining, and all of the rents, issues and profits which may arise or be had therefrom.

TO HAVE AND TO HOLD the premises unto Mortgagee, its successors and assigns, forever, for the purposes, and upon the uses herein set forth.

CONDITIONED, HOWEVER, That if

Mortgagors shall pay or cause to be paid to Mortgagee, at its office in the City of Milwaukee, Wisconsin, the principal sum of Twelve thousand dollars as follows, viz.: One thousand dollars thereof on April 27, 1952; one thousand dollars thereof on April 27, 1953, nine thousand dollars thereof in twelve instalments of seven hundred fifty dollars each, on April 27, 1954 and annually thereafter, and the remaining one thousand dollars thereof fifteen years from the date hereof, - - -

2.
