MORTGAGE

THIS INDENTURE, Made this 5th day of October, 1951, by and between
LAWRENCE HOUSING, INC.
of the State of Kansas, Mortgagee, and
THE PRUDENTIAL INVESTMENT COMPANY
under the laws of the State of Kansas, Mortgagee:

WITNESSETH, That the Mortgagor, for and in consideration of the sum of Nine Thousand Four Hundred Fifty and no/100 ----- Dollars (\$ 9,450.00), the receipt of which is hereby acknowledged, does by these presents mortgage and warrant unto the Mortgagee, its successors and assigns, forever, the following-described real estate, situated in the County of Douglas State of Kansas, to wit:

(1) All of Lot Eighteen (18) and part of Lots Seventeen (17) and Nineteen (19), Block Five (5), Park Hill Addition to the City of Lawrence, Douglas County, Kansas, as shown by Sheet Two of Plat of said Addition recorded in the Office of the Register of Deeds of Douglas County, Kansas, September 19, 1951, all more particularly described as follows: Commencing at a pin on the front or Northern boundary line of Lot 19, which point is 7.09 feet Northeasterly of the Northwestern corner of said Lot 19; thence in a Southwesterly direction along the chord of the front arc marking the Northern boundary line of Lots 19, 18 and 17, Block 5, 80.79 feet to a pin located 5.80 feet Southwesterly of the Northeastern corner of said Lot 17; thence in a Southeasterly direction along a radial line 126.05 feet to a pin located on the rear or Southern boundary line of Lot 17 which is 4.41 feet Southwesterly of the South eastern corner of said Lot 17; thence in a Northeasterly direction along the rear or Southern boundary line of Lot 17, 18 and 19, 62.86 feet to a pin located 5.50 feet Northeasterly of the Southwestern corner of Lot 19; thence in a Northerly direction 125.73 feet along a radial line to the point of beginning, subject to reservations, restrictions and easements of record.
