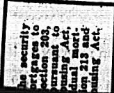

WITNESSETH, That the Mortgagee, for and in consideration of the sum of Nine Thousand Four Hundred Fifty and no/100 ----- Dollars (\$ 9,450.00), the receipt of which is hereby acknowledged, does by these presents mortgage and warrant unto the Mortgagee, its successors and assigns, forever, the following-described real estate, situated in the County of Douglas State of Kansas, to wit:

Part of Lots One (1), Two (2) and Nineteen (19), Block Five (5), Park Hill Addition to the City of Lawrence, Douglas County, Kansas, as shown by Sheet Two of Plat of said Addition recorded in the Office of the Register of Deeds, Douglas County, Kansas, September 19, 1951, all more particularly described as follows: The West 20 feet of Lot 1, and the West 20 feet of the North half of Lot 2 and all of Lot 19 except the following tract; commencing at a point on the Northwestern corner of Lot 19; thence Northeasterly 7.09 feet along the front or Northern boundary line of Lot 19; thence in a Southerly direction along a radial line 125.73 feet to a pin located on the rear or Southern boundary line of Lot 19, which is 5.50 feet Northeasterly of the Southwestern corner of Lot 19; thence Southwesterly along the rear or Southern boundary line of Lot 19, 5.50 feet to the Southwestern corner of Lot 19; thence in a Northerly direction along the Western boundary line of Lot 19, 126.16 feet to the place of beginning, subject to reservations, restrictions and easements of record.
