This mortgage is given to secure the payment of the principal sum of Ton Thousand Three Hundred and 00/10/Pollars (\$ 10,300,00), as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, payable with interest at the rate of the date of the quarter per centum ( 4,2 %) per annum on the unpaid balance until paid, principal and interest to be paid at the office of -The Fidelity Lyestment Company in Wichita, Kansas at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-three and 86/100 - - - -Dollars (\$ 63.86 encing on the first day of July , 19 52 , and on the first day of each month thereafter, until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of June , 19 72 . The Mortgagor covenants and agrees as follows: 1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity: Provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment; and provided further that in the event the debt is paid in full prior to maturity and at that time it is insured under the provisions of the National Housing Act, he will pay to the Grantee an adjusted premium charge of one per centum (1%) of the original principal amount thereof, except that in no event shall the adjusted premium exceed the aggregate amount of premium charges which would have been payable if the mortgage had continued to be insured until maturity; such navment to be enabled by the Continued to be insured until maturity; such payment to be applied by the Grantee upon its obligation to the Federal Housing Commissioner on account of mortgage insurance. That, together with, and in addition to, the monthly payments of principal and interest payable der the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee until the said note is fully paid, the following sums: (a) If this mortgage and the note secured hereby are insured under the provisions of the National Housing Act and so long as they continue to be so insured, one-twelfth  $\binom{1}{12}$  of the annual mortgage insurance premium for the purpose of putting the Mortgagee in funds with which to discharge the said Mortgagee's obligation to the Federal Housing Commissioner for mortgage insurance premiums pursuant to the applicable provisions of the National Housing Act, as amended, and Regulations thereunder. The Mortgagee shall, on the termination of its obligation to pay mortgage insurance premiums, credit to the account of the Mortgagor all payments made under the provisions of this subsection which the Mortgagee has not become obligated to pay to the Federal Housing Commissioner. (b) A sum equal to the ground rents if any and the taxes and special assessments next due on the sum equal to the product remain a many same to the premises overed by this mortgage, plus the premiums that will next become due and payable on policies of fire and other hazard insurance on the premises covered hereby (all as estimated by the Mortgagee) less all sums already paid therefor divided by the number of months to elapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes and special assessments, before the same become delinquent. (c) All payments mentioned in the two preceding subsections of this paragraph and all payments to be made under the note secured hereby shall be added together and the aggregate amount thereof shall be paid by the Mortgagor each month in a single payment to be applied by the Mortgagee to the following items in the order set forth: (1) premium charges under the contract of insurance with the Federal Housing Comground rents, if any, taxes, assessments, fire and other hazard insurance premiums; (III) interest on the note secured hereby; and (IV) amortization of the principal of said note. Any deficiency in the amount of such aggregate monthly payment shall, unless made good by the Mortgagor prior to the due date of the next such payment, constitute an event of default under this mortgage. The Mortgagee may collect a "late charge" not to exceed two cents (24) for each dollar (31) of each payment more than fifteen (15) days in arrears to cover the extra expense involved in handling delinquent payments. That if the total of the payments made by the Mortgagor under (b) of paragraph 1 preceding shall exceed the amount of payments actually made by the Mortgagee for ground rents, taxes and assessments payments of the same nature to be made by the Mortgagor. If, however, the monthly payments made by payments or the same matter to be made by the attendance of the sufficient to pay ground rents, taxes and the Mortgagor under (b) of paragraph 2 preceding shall not be sufficient to pay ground rents, taxes and assessments or insurance premiums, as the case may be, when the same shall, become due and payable, then the Mortgagor shall pay to the Mortgagor any amount necessary to make up the deficiency, on or the true mortgager chan pay to the mortgager and amount necessary to make up the demonstration before the date when payment of such ground rents, taxes, assessments, or insurance premiums shall be due. If at any time the Mortgager shall tender to the Mortgager, in accordance with the provisions of the note secured hereby, tail payment of the entire indebtedness represented thereby, the Mortgagee shall, in puting the amount of such indebtedness, credit to the account of the Mortgagor all payments made or the provisions of (a) of paragraph 2 hereof, which the Mortgagor has not become obligated to pay to the Federal Housing Commissioner, and any balance remaining in the funds accumulated under the provisions of (b) of paragraph 2 hereof. If there shall be a default under any of the provisions of Recorde
